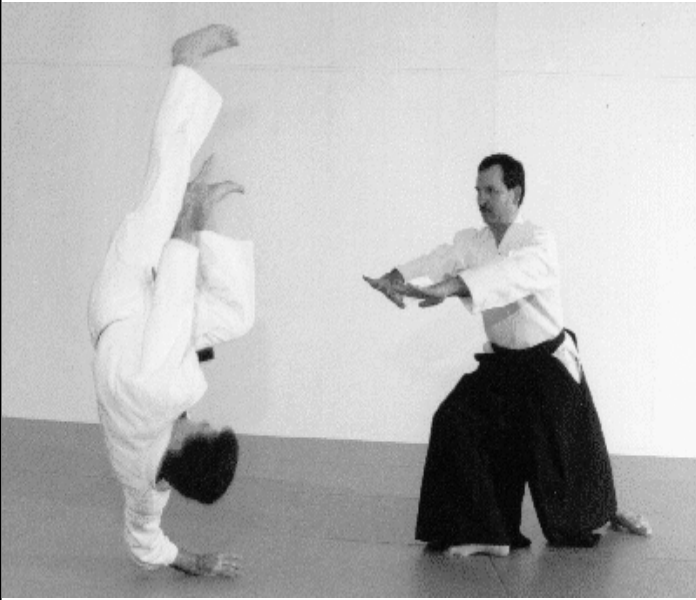


Aikido Seminar
